## **DESCRIPTION:**

The Durham County Department of Public Health (DCoDPH) is responsible for public health programs for the entire community. Major services include education, communicable disease control, maternal and child health services, dental health, laboratories, and vital statistics. The Department also regulates sanitation in food-handling establishments, monitors solid waste disposal and conducts disease prevention programs. Regional and local efforts are also being directed towards bioterrorism, disaster preparedness and pandemic response.

## **POSITION DESCRIPTION:**

Currently, the department is going into its second year of implementing the agency's strategic plan. The four strategic priority areas of the plan are:

- Community Focus and Engagement
- Workforce Development and Engagement
- Advance Racial & Health Equity
- Continuous Quality Improvement

The intern would assist with the implementing and evaluation of the progress made towards these priorities. In addition, the intern will have the opportunity to participate in several ongoing projects at the health department with multiple committees. The intern will conduct research around best practices for workforce development, quality improvement, and creating an equitable workplace.

- 4. Review and analyze employee survey results to provide recommendations for improving the agency's employee experience.

## WORK AUTHORIZATION: U.S. Citizen, Permanent U.S. Resident

Citizenship statement: The Region IV Public Health Training Center is a federally-funded program which has a citizenship requirement. To be eligible to apply for this position, you must be either a U.S. citizen, a non-citizen U.S. national, or a foreign national having in your possession a visa permitting permanent residence in the U.S.

#### AWARD LEVEL: \$3,500 award

\* Note: Travel costs will not be covered by the program beyond the total \$3,500 award.

#### APPROXIMATE HOURS PER WEEK & DURATION: Approximately 15-20 hours a week for 12 weeks.

\*Students may be limited in the minimum or maximum number of hours they can work per semester based on their university, school or degree's policies. If this work will be also be used as a graduation requirement, the student should verify those requirements and abide by their university policies.
