### **DESCRIPTION:**

The following position is offered as a field placement through the Region IV Public Health Training Center (<u>https://r4phtc.org/</u>).

Note: This will be a hybrid placement. The placement will primarily be in-person, however there will be opportunity to do some remote work throughout the semester depending on needs and schedules.

The mission at Aletheia House is to provide comprehensive services to vulnerable individuals that increase their opportunities to lead successful lives. The values of the organization include:

- Providing high quality, evidence-based services
- servicing those who are in greatest need regardless of their ability to pay
- Providing services that are accessible to the populations of focus
- Providing services with "a special kind of caring"

Aletheia House is a private, not-for-profit community-based organization that provides the following services to the community: Substance Use Disorder Treatment, Affordable Housing, Employment Services, HIV Services, Healthcare Services, and Substance Use Prevention and Community Wellness services.

We have programs located throughout the state in: Huntsville, Muscle Shoals, Birmingham, Bessemer, Montgomery, Selma, Opelika, and Salem.

#### **POSITION DESCRIPTION:**

The student will have the opportunity to conduct work that aligns with both organizational needs and student learning objectives. The student may engage in hands-on prevention services to support our substance use prevention grants, such as facilitating educational sessions or developing community outreach materials. They may also assist with data collection by conducting intake and follow-up

surveys, which are critical for outcomes reporting and program evaluation. Additionally, the student can contribute to data analysis, ensure quality assurance, and prepare detailed reports to inform decision-making and demonstrate program impact. Opportunities to conduct focus groups are also available, allowing the student to gather qualitative data to support needs assessments and drive agency improvements. With a wide range of projects, the student will gain practical experience in public health programming, evaluation, and data-driven decision-making while contributing meaningfully to the agency's mission. The areas these tasks would support primarily include substance use disorder treatment, substance use prevention, healthcare, and HIV services.

## PREFFERED QUALIFICATIONS:

- Previous coursework or experience in public health, data analysis, or program evaluation.
- Strong written and verbal communication skills for conducting surveys, focus groups, and preparing reports.
- Experience with or interest in substance use prevention, health education, or community outreach.
- Ability to work both independently and collaboratively in a team environment.
- Strong organizational skills and attention to detail to ensure data quality and task completion.

## **REQUIRED QUALIFICATIONS:**

- Ability to commit to the agreed-upon internship schedule, with flexibility based on agency and student needs.
- Basic proficiency with Microsoft Office Suite, particularly Word, Excel, and PowerPoint.
- Demonstrated professionalism and the ability to maintain confidentiality in handling sensitive information.
- Strong interpersonal skills for engaging with clients, staff, and community stakeholders.
- Interest in gaining practical experience in public health programming, evaluation, and/or prevention services.

## THE STUDENT WILL HAVE THE OPPORTUNITY TO ASSIST WITH THE FOLLOWING ACTIVITIES:

- 1. Data Collection
  - a. Conduct intake and follow-up surveys with program participants to gather quantitative data for outcomes reporting.
  - b. Ensure accuracy and completeness of collected data, maintaining confidentiality and ethical standards.
- 2. Data Analysis and Reporting
  - a. Perform basic data analysis to identify trends and assess program effectiveness.
  - b. Assist in preparing detailed outcome reports for internal stakeholders and funders.
  - c. Support quality assurance efforts by reviewing data for accuracy and consistency.
- 3. Prevention Service Delivery
  - a. Assist in planning, organizing, and delivering substance use prevention services, such as educational workshops or community outreach events.
  - b. Develop materials (e.g., flyers, presentations, handouts) to support prevention initiatives.
- 4. Focus Group Coordination
  - a. Plan and facilitate focus groups with clients, staff, or stakeholders to collect qualitative data for needs assessments.

- b. Analyze focus group findings to generate actionable recommendations for program improvement.
- 5. Program Evaluation Support
  - a. Assist in developing or refining evaluation tools, such as surveys or logic models, to measure program impact.
  - b. Contribute to drafting evaluation plans and integrating feedback into operational practices.

  - Writing Sample

#### WORK AUTHORIZATION: U.S. Citizen, Permanent U.S. Resident

Citizenship statement: The Region IV Public Health Training Center is a federally-funded program which has a citizenship requirement. To be eligible to apply for this position, you must be either a U.S. citizen, a non-citizen U.S. national, or a foreign national having in your possession a visa permitting permanent residence in the U.S.

#### AWARD LEVEL: \$3,500 award

\* Note: Travel costs will not be covered by the program beyond the total \$3,500 award.

APPROXIMATE HOURS PER WEEK & DURATION: Approximately 10-20 hours a week for 12-16 weeks.

\*Students may be limited in the minimum or maximum number of hours they can work per semester based on their university, school or degree's policies. If this work will be also be used as a graduation requirement, the student should verify those requirements and abide by their university policies.
