DESCRIPTION:

The following position is offered as a field placement through the Region IV Public Health Training Center (<https://r4phtc.org/>).

NOTE: This position will be conducted on a hybrid basis. The ideal student would be able to visit their preceptor for initial introduction and be able to meet in person with providers at least every week.

The Florida Department of Health in Monroe County serves the residents of and visitors to the Florida Keys. DOH-Monroe maintains three sites from Key West to Tavernier, including three clinics, three community health services offices and an administrative center. Our Mission– To protect, promote & improve the health of all people in Florida through integrated state, county & community efforts.

POSITION DESCRIPTION:

Over the past few years, the Florida Department of Health in Monroe County has been dedicated to enhancing communication and access to healthcare services, particularly by connecting residents to health providers. This initiative focuses on linking residents with providers across various specialties, including those who accept uninsured or underinsured patients.

Given that the Florida Keys span over 120 miles of islands, the Access to Care (ATC) app was launched to improve awareness of healthcare providers in the region. The ATC app, available as both a website and a smartphone application, allows users to search for healthcare providers, refine their search by specialty, insurance type, and availability of discounted rates for uninsured or underinsured patients.

Currently, healthcare providers and practice groups can sign up to be featured in the app. With approximately 300 healthcare providers serving Monroe County, the goal is to have at least 80% of these providers registered before the app is launched to the public. Achieving this target will maximize the app's effectiveness and ensure that residents have access to a comprehensive network of care, including specialty services.

The app is designed to be user-friendly, allowing residents to easily locate specific providers in their area. It also enables providers to update their information in real-time, including changes in practice status, insurance options, and patient intake capacity. The ATC app will be available in English, Spanish, and Haitian Creole, ensuring accessibility for a diverse population.

The student will lead the efforts to onboard healthcare providers to the ATC app. This role involves engaging providers through phone calls, emails, and in-person visits to encourage their participation. Using an existing spreadsheet of healthcare providers in the Florida Keys, the intern will work to ensure a high uptake of providers.

This internship offers a unique opportunity to contribute to an innovative healthcare solution that will ultimately benefit countless residents of the Florida Keys. By leveraging the Department's resources and the intern's proactive outreach, the ATC app aims to revolutionize healthcare access in the region.

PREFERRED QUALIFICATIONS:

- Excellent interpersonal and communication skills
- Public speaking skills
- Ability to juggle multiple tasks simultaneously

REQUIRED QUALIFICATIONS:

- Well-versed in Microsoft Office (Outlook, Word, and Excel)
- Typing speed at minimum 40 words per minute

THE STUDENT WILL HAVE THE OPPORTUNITY TO ASSIST WITH THE FOLLOWING ACTIVITIES:

1. Outreach to Healthcare Providers
 - a. Make phone calls, send emails, and conduct in-person visits to engage and persuade providers to sign up for the ATC app.
2. Data Management and Tracking
 - a. Maintain accurate records of provider contacts and their responses.
 - b. Track progress towards the goal of having 80% of healthcare providers signed up.
 - c. Update the spreadsheet with new information and ensure data integrity.
3. Assistance with Provider Onboarding
 - a. Guide providers through the signup process for the ATC app.
 - b. Assist providers in entering their information accurately into the app.
 - c. Offer technical support as needed to ensure a smooth onboarding experience.
4. Follow-up and Updates
 - a. Conduct follow-up communications with providers who have not yet signed up.
 - b. Remind providers to update their app profiles with changes in practice status, insurance options, or patient intake.
5. Feedback Collection and Reporting
 - a. Gather feedback from providers on their experience with the signup process and app functionality.
 - b. Report findings to the Florida Department of Health in Monroe County for continuous improvement of the ATC app.
6. Community Engagement

- a. Collaborate with local healthcare groups and community organizations to raise awareness about the ATC app.
- b. Participate in community events to promote the app and its benefits to both providers and residents.

WORK AUTHORIZATION: U.S. Citizen, Permanent U.S. Resident

Citizenship statement: The Region IV Public Health Training Center is a federally-funded program which has a citizenship requirement. To be eligible to apply for this position, you must be either a U.S. citizen, a non-citizen U.S. national, or a foreign national having in your possession a visa permitting permanent residence in the U.S.

AWARD LEVEL: \$3,500 award

* Note: Travel costs will not be covered by the program beyond the total \$3,500 award.

APPROXIMATE HOURS PER WEEK & DURATION: Approximately 20-30 hours a week for 10-12 weeks.
